DENNIS GOLF MEMBERSHIP POLICY REMINDERS

MEMBERSHIP REFUND POLICY

- 1. Any member may receive a full refund of membership for any reason before March $1^{\rm st}$ of current membership year.
- 2. Any member may receive a full refund under the following conditions:
 - Documentation of a serious medical condition must be presented to the Director of Golf within 60 days after membership has been paid.
 - No more than 3 rounds of golf have been played since the membership payment was made. If 1, 2 or 3 round(s) of golf have been played then the cost of the green fee associated with the round(s) of golf will be deducted from the money refunded.
 - The 60-day period of eligibility for a refund does not go past June 30th of the current membership year.

RESIDENT FREEZE AGE POLICY

Those members who fell into the Resident Freeze I, Freeze II, and Freeze III categories remain in said categories so long as you renew your membership each consecutive year. Any break in membership results in a void of the Freeze category and you will be assessed the full Resident Membership rate in any subsequent year.

AGE (JUNIOR, YOUNG ADULT, 23-29) RESIDENT & NON RESIDENT

<u>Juniors (12-18)</u>: in order to qualify for the Junior Membership rate, you must remain age of 18 or younger throughout the entire membership year (March 1st thru February 28th). Any member turning age 19 within the membership year will be assessed the Young Adult Membership rate.

<u>Young Adults (19-22):</u> in order to qualify for the Young Adult Membership rate, you must remain age of 22 or younger throughout the entire membership year (March 1st thru February 28th). Any member turning age 23 within the membership year will be assessed the Age 23-29 membership rate.

Resident Age 23-29: in order to qualify as a resident, you or your parents must reside in the Town of Dennis. Proof of residency will be required. If parents are residents, verification such as a birth certificate, is required. In order to qualify for the Age 23-29 membership rate you must remain age of 29 or younger throughout the entire membership year (March 1st thru February 28th). Any resident member turning age 30 within the membership year will be assessed the Resident Membership rate and must provide proof of residency (tax bill or year long lease agreement).

Non-Resident Age 23-29: in order to qualify for the Non-Resident Age 23-29 rate, you must remain age of 29 or younger throughout the entire membership year (March 1st thru February 28th). Any Non-Resident Member turning age 30 within the membership year will be assessed the Non-Resident membership rate.

ALCOHOL USE POLICY

Alcoholic Beverages not purchased through our restaurant(s) are prohibited on Golf Course Property. All coolers are subject to search. If alcohol is observed, golf course personnel will direct players to either empty the open container(s), or, when appropriate, remove the alcohol from the course. If the party refuses to follow directives from any Golf Department Staff, a Supervisor will be notified and Police Assistance may be requested, if necessary.

NON-MEMBER JUNIOR PLAY

Any junior (aged 18 or under) may play for \$15.00 after 3:00 p.m. daily provided said junior(s) are accompanied by a Dennis Golf Member or Paying Adult. Unsponsored Non-Member Juniors will be subject to the appropriate greens fee.

AGE 65+ GREENS FEE (9 HOLES)

Any person aged 65+ may play 9 holes after 2:00 p.m. or Early Back 9 Monday through Thursday for a greens fee of \$30.00. Advanced registration of tee times is prohibited and deal is only available on day of play only.

EARLY BACK 9 PLAY

Early Back 9 Play will now be done through the tee time making process through Chelsea Reservations. Early Back 9 will occur at both golf courses between Monday-Thursday during the months of April through November on every other week basis (some weeks may have no back 9 due to aeration or events scheduled-check the calendar online). Both golf courses will offer early back 9 play on Fridays, Saturdays, Sundays and Holidays unless otherwise noted on the events calendar on the Dennis Golf website. Please remember to make your requests for 9 holes instead of 18 when requesting early back 9 tee times.

LAST CART TIME

An established last cart time will be posted on the website and Pro Shops throughout the year. No carts will be rented to any member or guest after the posted last cart time for any circumstance.

DRIVING RANGE USE

Use of personal golf balls on the driving ranges is strictly prohibited. All range balls purchased through Dennis Golf are property of the Town of Dennis and should not leave the premises at any time. Driving ranges will be closed weekly for clean picking and mowing, based on the following schedule:

Dennis Highlands Golf Course- Range closes 3:00 p.m. Wednesday

Dennis Pines Golf Course- Range closes 3:00 p.m. Tuesday

Range cards may be used after Pro Shop closes.

NO SHARED CLUBS

In order to ensure accurate pace of play, all players must have their own set of clubs to be played with during all times on the golf course. Both Dennis Highlands and Dennis Pines Golf Courses have full-set rental clubs available for a set fee. There is no sharing of bags between players at any given time during the golf round.
